The Town Centre Chaplaincy has two main aims:

- Enhance understanding, trust and cooperation between communities of work, faith, leisure and society;
- Provide a caring, listening and supportive presence for anyone who lives in, works in or visits the town centre.

We run 3 distinct projects, to support people in different ways:



Care and support for vulnerable young people & adults on Guildford's streets, every Friday and Saturday night

Street Angels have been serving people on Guildford's streets since October 2008 and make a positive impact on crime and antisocial behaviour by providing a calming presence late at night.

Our volunteers visit people in their homes, providing companionship and support to reconnect with the local community. Support is personalised and may range from chatting over a cup of tea to going for walks, trying a new activity, or accessing other types of help.
